This warranty is made to the original owner only, and is limited to residential applications within the United States. This warranty is not transferable to subsequent owners. This warranty applies only to manufacturer defects and does not apply to the mellowing and aging of any wood products appearance due to photo-degradation (effect of natural and artificial light to woods and finishes). The inherent characteristics of wood include a certain amount of mineral streaks, pin knots and color and grain variations. These fluctuations in wood are natural and are not considered defects.

THIS WARRANTY DOES NOT COVER DAMAGE DUE TO: shipping; delivery; improper storage before or after installation; abuse; neglect; improper installation; improper cleaning; failure to keep the product clean; exposure to moisture, extreme temperatures, humid conditions or any use of said product for any purpose other than designated by the manufacturer.

Warning: *Environmental conditions may affect wood and wood related products adversely such as warping, cracking, contraction, expansion, delaminating or other aberrations and are not covered in this warranty.*

No oral or written information or advice given by DeWils Industries, Inc. or its dealers, agents or employees shall create any warranty or increase the scope of the limited warranty provided under this agreement.
