



CABINETRY: LIMITED ONE-YEAR WARRANTY

Warranty Coverage One Year Limited Warranty on Cabinets

RidgeCrest Custom Cabinetry (RCCC) warrants to the original purchasing consumer, for residential applications only, that the cabinetry provided will be free from defects in material or workmanship that arise under normal use and service for one (1) year from the date of original purchase or as long as the original purchasing consumer owns the home, whichever is less.

Warranty Disclaimers

This warranty is not transferable. Natural woods may vary in texture, color, and wood grain, and exhibit subtle changes as they age. Sunlight, UV light, smoke, moisture, household cleaners and other environmental conditions may cause material to vary from their original color and/or warp, split or crack. These variations are the nature of the material in relation to its environmental exposure and are not covered by this warranty. For these reasons, new and/or replacement cabinets may not match display samples and/or existing cabinets. Such variations and changes are not considered defects.

Warranty Exclusions

THIS WRITING IS THE COMPLETE AND EXCLUSIVE STATEMENT OF THE EXPRESS WARRANTIES PROVIDED HEREIN AND IS IN LIEU OF ALL OTHER EXPRESS AND/OR STATUTORY WARRANTIES BY THE MANUFACTURER, TO THE EXTENT PROVIDED BY LAW. THERE ARE NO IMPLIED WARRANTIES EXTENDING BEYOND THE TERMS OF THIS WARRANTY. RCCC SHALL NOT BE LIABLE FOR ANY INCIDENTAL OR CONSEQUENTIAL COSTS, EXPENSES, OR DAMAGES. Some states do not allow limitations or exclusions of incidental or consequential damages, so the above limitation and exclusions may not apply to you. This warranty gives you specific legal rights and you may have other legal rights which vary from state to state.

Warranty Limitations

This warranty is expressly limited to repair or replacement of the defective part at the discretion of RCCC and does not include costs associated with transportation or labor for removal, replacement, or installation of defective product. This warranty does not extend to any product used or installed in connection with cabinets, such as gas or electric appliances, countertops or plumbing fixtures. This warranty does not extend to damage caused by transportation, storage, or exposure to excessive temperatures or to defects arising from misuse, neglect, accident, alternation, improper use or care or failure to maintain.

Warranty Claims

All claims for defective cabinets and accessories must be submitted through Pacific Cabinetry and Design. After Pacific Cabinetry and Design has had the opportunity to inspect the cabinets and accessories, RCCC will, at their discretion, either replace defective cabinets and accessories or repair any defects in the cabinets and accessories.

Because maple has such tight grain, pigment type stains don't soak into the wood, except where there is a spot with more open grain.
